

Council Approves New Safety Contract



The Council approved the Ross Police Officers Association Memorandum of Understanding for the term July 2015 to June 30, 2019. The MOU between the Town and Police Officers Association expired on June 30, 2015. The provisions of the MOU stay in place until a new MOU is negotiated. After several months of negotiations the Town and the Police Officers Association have come to agreement on a new MOU. Key provisions in the new MOU include:

The fiscal impact from the new MOU in the current fiscal year is an increase of approximately \$24,000 excluding health insurance which employees will start paying a portion of after January 1, 2016. The Police Department budget for the year total is \$1,473,000 of which \$1,291,000 is for salary and benefits. ■

Town Seeks Resident for Board Vacancy

The Town is seeking an interested resident to fill a board vacancy on the Marin/Sonoma Mosquito & Vector Control District Board of Trustees. To serve on this committee, you must be a registered voter and reside in Ross. New appointees begin by serving a two-year term from January 2016 to December 2018.



The Board of Trustees meetings are held monthly at 7:00 pm on the second Wednesday of each month at District Headquarters in Cotati. Each member is compensated \$100 per Board meeting for travel expenses (not to exceed \$100 per month).

If you would like to be considered for this appointment by the Town Council, please provide a brief statement with any relevant background you may have in serving on boards or commissions. Preference will be given to those who have experience, training, and education in fields that will assist in the governance of the District. Submit your response via email to Linda Lopez at llopez@townofross.org by December 1, 2015. The Council will review submissions at the December 10th Council meeting and select an appointment at that time.

Please don't leave valuables in your car in plain sight. Park in well lighted areas and use facilities that have security if possible.



6 Redwood House Clean-Up

The Town is contracting with American Technologies, Inc. (ATI) for the cleanup of the fire-damaged Town property at 6 Redwood Drive. Special procedures are necessary due to the presence of lead-based paint in a burned structure. The work will include lead abatement, HEPA vacuuming, removal and disposal of contaminated materials, and boarding up of the premises. Work is scheduled to begin in early November and is anticipated to take a maximum of four weeks. Once the work is completed, the Council will discuss the next step for the 6 Redwood Drive property, at a future Council meeting.
